#### 5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid

**6 PAYMENTS**

- 6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.
- 6.1.4 Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

## TERMS OF REFERENCE (TOR)

### Installation of 2 X Radio Studios

#### 1. Introduction

Installing and integrating a radio broadcast system presents many unique challenges and require a highly specialised skillset. NEMISA is seeking to appoint a Radio Studio Installation Supplier to implement its plans to install an On-Air and Production Studio at its Campus in Parktown. The quality of the equipment and installation should be consistent and reliable with current industry standards and appropriate for NEMISA's teaching and learning objectives.

#### 2. Background

After conducting a Studio Assessment Report for the Radio and Television Studios at NEMISA Parktown Campus, NEMISA is seeking to install 1 X New Radio Studio (On-Air) and 1 X Radio Studio (Production Studio). The Production Studio is built by repurposing its existing equipment. The Technical and Functional Assessment Report identified Radio Studio Equipment, Cables and Devices which are still operational and can be repurposed into a second studio.

#### 3. Summary

Consultancy Stage	Generic Objective
Consultancy	Provide a Proposal with Quotation for the Installation of On Air and Production Studios which would be fully operational for recording; production and broadcast purposes.

This document defines the purpose; activities to be done; expected issues to be reported; expertise required and budget set aside.

#### 4. Purpose and Activities:

The broad purpose is:

- To provide NEMISA with a Quote to Install 2 X Radio Studios (Production and On-Air) which would be fully operational for recording, production and broadcast purposes.

- The bid should include the procurement of equipment; **labour; installation; cabling and documentation for the On Air Digital studio which is linked to a separate presentation booth.**
- The quotation should also include the labour and installation of the **Production Studio using NEMISA existing equipment and repurposing it into a second studio also linked to the presentation booth.**
- The range of equipment procured for the On-Air studio should include **audio console; condenser microphones; microphone arms; studio monitor speakers; level meters; playout software; separate cue speaker; headphones; on-air-lights; telephone hybrid; a CD player; digital clock; specified computer; touch screen monitors; studio chairs, digital recorder and external hard drive.**
- The presentation booth should be connected to both studios and have the essential equipment of **3 microphones; table stands or microphone arms; a guest panel for headphone controls; headphones; microphone cables; rag lights.**
- The option of a **Rack Room to accommodate the server computers.** There should be two playout computers on the network with a production studio to avoid dependence of memory sticks
- The **second** Production Studio will be assembled **with NEMISA existing equipment (primarily analogue) and includes dynamic microphones; audio console; monitor speakers; CD players; telephone hybrid; cassette players; audio distribution amp; fitment racks and patch bay racks. New equipment includes studio clock; on-air lights and other necessary equipment.**
- **2x Computer specs should consider: i5 Processor; 240 Gb; 8Gb RAM; 4Tb External Drive**

#### 5. Implementation applied to which studios:

- Second Floor: Studios (Main Door sf 27; 28 and 30)
- Third Floor: Rack Room or Server Room

#### 6. Mandatory Requirements:

- Ten years' experience of studio installation

- Assembled and Installed within 4 – 6 weeks after notification of award.

**1 EVALUATION PROCESS**

**1.1 PRE-QUALIFICATION**

Bids received from bidders who have a Level 4 to 8 B-BBEE contributor status or a is a non-compliant contributor, will not be considered for evaluation and will be eliminated from further evaluation. EME and QSE at a minimum level of 3 will also be acceptable.

**Bidders who did not attend the compulsory briefing session will not be considered.**

**1.2 COMPLIANCE WITH MINIMUM REQUIREMENTS**

1.2.1 All bids duly lodged as specified in the Request for Bid will be examined to determine compliance with bid requirements and conditions. Bids with obvious deviations from the requirements/conditions will be eliminated from further consideration.

1.3.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

**1.4 DETERMINATION OF SCORE FOR PRESENTATIONS**

1.4.1 NEMISA **may** decide to have compulsory presentations made either by all bidders who have obtained at least **70%** of the marks for functionality, or by the bidders ranked first to a maximum of four, but not less than the three highest scoring bidders.

1.4.2 Presentations shall only affect the marks awarded for functionality. If NEMISA wishes to use presentations to discriminate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.3.1.

1.4.3 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated. Such score will be added to the original score for functionality.

1.4.4 A bidder will be disqualified if the combined score for functionality fails to meet the minimum threshold for functionality as per paragraph 1.4.1.

**1.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY**

1.5.1 Bids that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

**1.6 PRICE AND B-BBEE STATUS LEVEL POINTS**

1.6.1 All remaining bids will be evaluated as follows:

1.6.2 The **80/20** preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.

1.6.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.6.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.

1.6.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.6.4 or to a lower scoring bid on justifiable grounds.

**1.7 ADJUDICATION OF BID**

1.7.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
