#### 5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

## TERMS OF REFERENCE (TOR)

### 1 BACKGROUND TO THE PROJECT

NEMISA hereby invites suitably qualified and reputable service providers to submit proposal for the provision of Refurbishment or alterations in the Parktown offices. The successful bidders should provide a space plan, upon an appointment to the interpret our draft layout and space norms into aesthetic and professional designed learning environment. The successful bidder must provide us with the electrical installation and electrical compliance certificate on completion of the entire work

### 2 CONTRACT PERIOD

2.1 The project should not take longer than a month to finalise.

### 3 ROLE AND OBJECTIVES

The role and the objective of this project will be to enable NEMISA to have functional classrooms and conducive learning environment which will accommodate learners. All the classrooms as identified in the plan must be able to accommodate 20 learners and with 20 learner workstations.

Service providers are requested to provide options to connect electrical wires, network plugins between poles or floor plugins plugs, one additional plug for the facilitator must be provided in the front of the classroom.

**1 EVALUATION PROCESS**

**1.1 PRE-QUALIFICATION**

- 1.1.1 Bids received from bidders who have a Level 7 to 8 B-BBEE contributor status or a is a non-compliant contributor, will not be considered for evaluation and will be eliminated from further evaluation
- 1.1.2 Service providers must submit a Valid COIDA certificates
- 1.1.3 Service provider must be CIDB registered (attach proof of registration). The construction must be Grade three (2GB) or higher rating, under class of work general building works. Failure to submit will result in the bid being disqualified

**1.2 COMPLIANCE WITH MINIMUM REQUIREMENTS**

- 1.2.1 All bids duly lodged as specified in the Request for Bid will be examined to determine compliance with bid requirements and conditions. Bids with obvious deviations from the requirements/conditions will be eliminated from further consideration.

1.3.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

**1.4 DETERMINATION OF SCORE FOR PRESENTATIONS**

1.4.1 NEMISA will not call for presentations.

**1.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY**

- 1.5.1 Bids that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

**1.6 PRICE AND B-BBEE STATUS LEVEL POINTS**

- 1.6.1 All remaining bids will be evaluated as follows:
- 1.6.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 1.6.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.6.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.
- 1.6.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark or to a lower scoring bid on justifiable grounds.

**1.7 ADJUDICATION OF BID**

- 1.7.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
