- 2.2.2 Bidders should bring their own copies of the bid documentation to the briefing session as bid documents will not be made available at the session.

For bids from consortium or Joint Venture, a representative of at least one of the organisations must attend the briefing. Bids from individuals, organisations or consortia of organisations that have not met the attendance requirements will not be considered.

#### **4 LATE BIDS**

- 4.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.
- 4.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.
- 4.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

#### **5 PAYMENTS**

- 5.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.
- 5.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.
- 5.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 5.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.
- 5.1.4 Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

## TERMS OF REFERENCE (TOR)

### 1. BACKGROUND INFORMATION

In her speech during the National Assembly Debate: Transform the Economy to serve the people (February 2019) the Honourable Minister Stella Ndabeni- Abrahams stated that:

*“The biggest task facing us as nation is how to build a capable 4IR Army that is required by the new industries and technologies. At the centre of our response therefore is a massive skills development programme”.*

*“It is in this regard that NEMISA will be transformed into a key digital skills academy for both public servants and our communities.*

NEMISA is thus responsible for the development of e-literacy capacity in South Africa and will endeavour to make educational courses available to all South Africans using an online e-content development mechanism in collaboration with its CoLabs (Partner universities and Universities of Technology), business and civil organisations.

NEMISA therefore needs a comprehensive Learning Management System (LMS) solution that will be able to address the challenges associated with scalability, maintainability, technology matching, digital integration, control and overall ownership in digitally skilling South Africans.

### 2. Contract period

Period of 36 Months post the LMS commissioning

### 3. Scope of work

NEMISA hereby invites experienced and reputable service providers to submit proposals for an Open Source NEMISA Learning Management System (LMS). This will be for a period of three (3) years.

NEMISA needs a comprehensive Learning Management System (LMS) solution that will be able to address the challenges associated with scalability, maintainability, technology matching, digital integration, control and overall ownership in digitally skilling South Africans.

The overarching architecture of the comprehensive LMS solution envisioned should be able to deliver an integrated and scalable solution that:

- Will be online, web-based and services to be cloud-based (hosting to be included as part of solution).

#### Registration & Management

- Will enable students to register / enrol online to a NEMISA database to obtain access to the organization's virtual learning cloud services in multiple ways, including mobile number, Google ID, email, etc.

- Registration site to prompt for all information to be completed before finalization of registration process
- Will allow individual registrations as well as bulk importing
- Will allow full course registration and management: assigning courses to course catalogues, groups or series based on predefined user roles or identification codes
- Will allow for the scheduling of training, specifically and individually, by the different CoLabs.
- Will have a public-facing homepage for non-registered users

**Content**

- Will include an online course authoring tool / course builder allowing for the creation and upload of course assets and content for courses by the CoLabs without bidder assistance
- Will have a robust multi-media content management system with support for video, audio, pdf, Word, PPT, etc. and have the ability to re-use content on multiple courses.
- Will have a Search function

**Training**

- It should be accessible anywhere and anytime – online and offline capability (offline course player) to deliver courses and micro-learning content
- It should also cater for classroom-based training (instructor-led), self-paced training, webinars, micro-learning.

**Assessment /Evaluation**

- Assessment engine will have native support for multiple types of questions, quizzes and tests with extensive reporting on all results and auto marking capabilities that automatically integrate with a plagiarism checker
- Will allow assignments in different formats, set conditions and deadlines according to course rules and prerequisites
- Will include an award system (certificates of completion / badges/ points) – built-in gamification tools
- Will include a survey engine to collect data on student engagement and course efficiency / satisfaction (built-in feedback system to collect and compile user data)
- Course prerequisites, course retake restrictions,

**Interoperability**

- Embedded LRS or external LRS to provide deeper analytics and collect data from external sources
- The platform should be SCORM compliant; it should have open-ended API to allow for integration with 3<sup>rd</sup> party software and scripts for data portability and transfer between systems used by different CoLabs
- Should also be able to interface with other existing LMS, such as that of IBM, Google, CISCO.

**Reporting**

- Will allow for live-time analytics as required by NEMISA, producing custom reports on any user, object or action within the portal, e.g. number of students trained per province/ course/ gender/ demographics / CoLab / National, user login activity, etc.
- Will include visual representations of data.

**Support**

- Will have 24/7 tech support and on-demand support for admin and normal users for uninterrupted service
  - Email support / phone support / support representative / helpdesk
  - System training (live, online, FAQs, helpdesk, Live Chat)

**Scalability**

- Will allow for flexibility, scalability, extendibility and multitenancy (divide portal into sub-portals according to CoLabs/ Focus areas; customize to operate independently) to match the organisation and adapt to training requirements.

**Communication**

- Will have an e-communication module which will offer native support for internal email, text messages to categorized users, calendars, discussion forums and comments and have tracking tools that monitor learner engagement and participation.
- Allow for easy integration and tracking of informal learning tools (discussions forums; blogs; etc.)

**eCommerce**

- The system should allow / make provision for a payment gateway for the paid courses on the system for future courses.

**Accessibility**

- The e-learning platform should be cross-browser compatible, fully responsive
- The eLearning platform should also be multiplatform accessible (responsive design).

**Customization**

- Should be graphically attractive (customize look and feel; integrate logo, colour scheme and other essential branding elements and domain on every page) and allow for smooth-user experience.

**Security**

- The platform should offer comprehensive security: access control, 2-step verification, segmentation, data integrity, data reliability, availability, accountability, authorization, application level security, data-encryption at rest and in transit, SSL.

## User experience

- Ability to self-register, change password, clear log-in
- Dashboard providing general overview of training course
- Intuitive navigation and search
- Engaging and visually appealing.

1.2.2 The proposal will be evaluated into two stages. A minimum of 70 points out of 100 points on technical capability will be the cut-off to qualify for further evaluation. Bidders who scored below points on technical evaluation will not be considered for the final stage (Price and B-BBEE), Bidders must score minimum of 70 points out of 100 points and above to qualify for the final stage of evaluation (Price in order to facilitate a transparent selection process that allows an equal opportunity to all bidders.

1.2.3 Proposal will be evaluated in terms of the prevailing Supply Chain Management policy applicable to NEMISA and it should be noted that proposals will be assessed using the 80/20 formula (Preference Points System) for Price and B-BBEE as indicated in the PPPFA Regulations of 2017.

1.3 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

#### 1.4 DETERMINATION OF SCORE FOR PRESENTATIONS

1.4.1 NEMISA may decide to have compulsory presentations made either by all bidders who have obtained at least **70%** of the marks for functionality, or by the bidders ranked first to a maximum of six, but not less than the three highest scoring bidders, once the price and preference marks have been combined.

1.4.2 Presentations shall only affect the marks awarded for functionality. If NEMISA wishes to use presentations to differentiate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2.1.

1.4.3 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated. Such score will be added to the original score for functionality.

1.4.4 A bidder will be disqualified if the combined score for functionality fails to meet the minimum threshold for functionality

**1.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY**

- 1.5.1 Bids that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

**1.6 PRICE AND B-BBEE STATUS LEVEL POINTS**

- 1.6.1 All remaining bids will be evaluated as follows:
- 1.6.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 1.6.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.6.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.
- 1.6.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark or to a lower scoring bid on justifiable grounds.

**1.7 ADJUDICATION OF BID**

- 1.7.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
