## 5 LATE BIDS

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

## 6 PAYMENTS

6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

6.1.4 Payment shall be made by bank transfer into the Contractor's bank account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

## **TERMS OF REFERENCE (TOR) FOR ASSET VERIFICATION**

### **1. INTRODUCTION**

The National Electronic Media Institute of South Africa (NEMISA) invites proposals for the provision of asset verification and asset valuation services. NEMISA has an existing asset register and requires the service provider to perform the services below:

### **2. SCOPE OF THE WORK**

2.1. The objective of this bid is to appoint a suitable independent service provider that can perform the following services as listed below:

- Performing Asset verification
- Updating (i.e Disposal, Addition) 2017/18 asset register with 2018/19 details and register – asset register that conforms with requirements of GRAP
- Preparing a final asset register to be used for 2018/19 AFS and Audit
- Depreciation calculation

**The contract is expected to run over 4 weeks, commencing on the date of signing the service level agreement**

Bid submissions should focus on the following aspects to qualify and be considered:

- ❖ Experience of the bidder in asset verification and valuation, including specialised skills, expertise and value-added services.
  - Demonstration of the bidder's asset management experience.
  - Specialised skills, expertise and value-added services in the field of asset management, with an emphasis on best practice methodology, tools and technology used.
- ❖ Experience in asset management in public entities by the bidder and /or team leader and team members.
  - Advanced understanding of, and sufficient exposure, to the Public Finance Management Act and the Protocol on Corporate Governance for Public Entities.
  - Experience in the asset management consulting of public entities by the bidder or team leader.
  - External references, the size of clients.
- ❖ Qualifications and experience of team member
  - The team leader must have at least 15 years audit/accounting experience, with the major part in accounting.
  - The team members should have accounting/auditing experience. Proof of experience must be supplied with the bid.
  - Detailed CVs of the team members who will be carrying out the assignment.
