3.3 Documents submitted on time by respondents shall not be returned.

4 LATE SUBMISSIONS

4.1 Quotations received late shall not be considered. A quotation will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and quotations arriving late will not be considered under any circumstances. Quotations received late shall be returned unopened to the respondent. Respondents are therefore strongly advised to ensure that quotations be despatched allowing enough time for any unforeseen events that may delay the delivery of the quotation.

4.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

4.3 Quotations sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises. Quotations received at the physical address after the closing date and time of the quotation, shall therefore be deemed to be received late. Quotations sent by email shall be deemed to have been received at the time indicated in the inbox of the recipient.

5 PAYMENTS

5.1.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor. The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

5.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

5.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

5.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the quotation is awarded).

TERMS OF REFERENCE (TOR)

1. PURPOSE

The National Electronic Media Institute of South Africa (NEMISA) hereby invites experienced and suitably qualified service providers to submit proposals for the development of the new NEMISA website (<http://www.nemisa.co.za/>) on open source platforms.

2. BACKGROUND

NEMISA is a training provider in creative media and digital skills. Recently, the mandate was expanded to include 4IR skills for South African citizens. The organization seeks to enlist the services of a developer to design and develop a new and interactive website which is dynamic and indicative of its professional image.

3. SCOPE OF WORK

The purpose of contracting the supplier is to design and develop the website, while ensuring it is dynamic and user friendly to all its audience and stakeholders. The website must be developed in either WAMP (Windows, Apache, MySQL, and PHP) or LAMP stack (Linux, Apache, MySQL, and PHP).

The successful bidder will be responsible for the development of the NEMISA website, using the latest web and intranet software, tools and techniques available (e.g. macromedia flash animation, artificial intelligence, data analytics, sound and graphics). This entails, ensuring that the website is functional, dynamic, easy to update for internal employees and easy to navigate as required by NEMISA.

This includes, but is not limited to:

- Design and development
- Transferring content from the current NEMISA website to the new website where required;
- Archiving old content with the approval of NEMISA;
- Integration of NEMISA social media accounts: Facebook, Twitter, Instagram, LinkedIn, Snapchat etc.;
- Redirection to the NEMISA digital skills platform/learning management system;
- Layout and typesetting;
- Maintenance of, and adherence to, the NEMISA industry identity standards;
- Video content and flash animation;
- Creating, maintaining and sustaining web security programming;
- Load and traffic balancing;
- Search engine optimization;
- Spelling checks and management;
- Immediately upload all approved NEMISA content onto the website when requested;

The current website has non-functional parts such as dead buttons, links, pages, and tabs. These need to be removed from the new site and the current tabs be rearranged.

6. TECHNICAL REQUIREMENTS

Web standards compliant code: Website will be developed in easily maintainable and effective code and using proven, best practice, coding languages for such a website. The programming language used to develop this website will be PHP on LAMP or WAMP stack

Language: Language to be used for on the website is English

User Interface: Menu-driven interface compatible with all browsers for mobile devices, tablets, and computers (any OS) – the user experience to be the same way on mobile phones as on their laptops, this is not the case with our current site.

Redesign the site to enable seamless sharing of our content. It will also make it possible to create and nurture an online community.

Exclusions: NO third-party frameworks may be used. This includes any 3rd-party open-source content management systems such as WordPress, Drupal, Joomla or Duda.

Permitted: Website to be coded using PHP 7.4 or newer version. Database development to be completed using MySQL 8 or newer. Apache will be used for the web server component.

7. UPDATES

The appointed service provider will obtain written approval from NEMISA before implementing any changes or updates to the website.

1.2.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.

- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual respondent for functionality.

1.3 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

- 1.3.1 Quotations that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.4 PRICE AND B-BBEE STATUS LEVEL POINTS

- 1.4.1 All remaining quotations will be evaluated as follows:

- 1.4.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.

- 1.4.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.

- 1.4.4 The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.

- 1.4.5 The Evaluation Committee may recommend that the contract be awarded to the respondent obtaining the highest aggregate mark as determined by 1.4.4.

1.5 ADJUDICATION OF BID

- 1.5.1 The relevant award structure will consider the recommendations and make the final award. The successful respondent will usually be the service provider scoring the highest number of points or it may be a lower scoring quotation on justifiable grounds or no award at all.
