5 LATE SUBMISSIONS

5.1 Quotations received late shall not be considered. A quotation will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and quotations arriving late will not be considered under any circumstances. Quotations received late shall be returned unopened to the respondent. Respondents are therefore strongly advised to ensure that quotations be despatched allowing enough time for any unforeseen events that may delay the delivery of the quotation.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Quotations sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises. Quotations received at the physical address after the closing date and time of the

6 PAYMENTS

6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

6.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

TERMS OF REFERENCE (TOR)

HOSTING THE NEMISA WEBSITE AND LMS SITE

1 PURPOSE

The National Electronic Media Institute of South Africa (NEMISA) hereby invites experienced and suitably qualified Internet Service Providers (ISP) to submit proposals for the hosting of the new NEMISA website (<http://www.nemisa.co.za/>) and Moodle Learning Management System (LMS) open source platforms.

2 BACKGROUND TO THE PROJECT

NEMISA is a training provider in creative media, digital skills, and recently its mandate has been expanded to include 4IR skills for South African citizens.

NEMISA is thus responsible for the development of digital -literacy capacity in South Africa and will endeavour to make educational courses available to all South Africans using an online e-content development mechanism in collaboration with its Stakeholders, Partner universities and Universities of Technology, business and civic organizations.

The organization seeks to secure the services of a reputable ISP to host our new website as well as the LMS on 12-month agreement. The prospective ISP will help NEMISA to address the challenges associated with scalability, maintainability, technology matching and digital integration among other things. May it be noted that NEMISA does not require the provision of an LMS but rather a hosting platform to which the existing LMS will be migrated.

3. Scope of Work

The purpose of contracting the supplier is to provide a managed hosting platform for the website and the NEMISA LMS while ensuring confidentiality, integrity, and availability of the two systems. The envisioned architecture should be able to deliver an integrated and scalable solution that will be able to cater for the increasing needs of NEMISA (Approximately **10 000** students within the first year). Bidders are advised that two (2) services are required i.e. website hosting and web-based LMS hosting services.

3.1 Website hosting

The website will be hosted on a Linux cloud website hosting service with all the required features as listed below. This service will be used to the new NEMISA website and may be a shared virtual private server.

3.2 LMS Hosting

For the hosting of the **Moodle LMS** NEMISA requires a cloud hosted managed server with the following minimum requirements. NEMISA has a LMS in place which will be migrated to new hosting services to be provided by prospective ISP. Therefore, NEMISA does NOT require the bidders to provide an LMS in their proposals. A dedicated virtual private server (VPS)would be preferred for the hosting of the LMS which will be accessed over the internet using a web browser.

The successful bidder will be responsible for the hosting and support of the two (2) services required. This includes the availability of the cPanel management platform for the hosting of the Moodle LMS. The prospective service provider will also provide basic training and access for NEMISA staff to the environment. The server resources must be scalable as and when the requirements change.

1 EVALUATION PROCESS

1.1 PRE-QUALIFICATION

Bids received from bidders who have a Level 4 to 8 B-BBEE contributor status or a is a non-compliant contributor, will not be considered for evaluation and will be eliminated from further evaluation.

1.3.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual respondent for functionality.

1.4 DETERMINATION OF SCORE FOR PRESENTATIONS

1.4.1 NEMISA will not call for presentations.

OR

1.4.2 NEMISA has decided/may decide to have compulsory presentations made either by all respondents who have obtained at least **70%** of the marks for functionality, or by the respondents ranked first to a maximum of six, but not less than the three highest scoring respondents, once the price and preference marks have been combined.

1.4.3 Presentations shall only affect the marks awarded for functionality. If NEMISA wishes to use presentations to discriminate between respondents, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2.1.

1.4.4 Points determined by the presentation will be awarded to each respondent by each member of the Evaluation Committee and then an average calculated. Such score will be added to the original score for functionality.

1.4.5 A respondent will be disqualified if the combined score for functionality fails to meet the minimum threshold for functionality.

1.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

1.5.1 Quotations that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.6 PRICE AND B-BBEE STATUS LEVEL POINTS

1.6.1 All remaining quotations will be evaluated as follows:

1.6.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.

1.6.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.

1.6.4 The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.

1.6.5 The Evaluation Committee may recommend that the contract be awarded to the respondent obtaining the highest aggregate mark as determined by 1.6.4 or to a lower scoring quotation on justifiable grounds.

1.7 ADJUDICATION OF BID

1.7.1 The relevant award structure will consider the recommendations and make the final award. The successful respondent will usually be the service provider scoring the highest number of points or it may be a lower scoring quotation on justifiable grounds or no award at all.
