6 LATE BIDS

6.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

6.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

6.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

7 PAYMENTS

7.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

7.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

7.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

7.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

7.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

TERMS OF REFERENCE (TOR)

THE PROVISION OF ONLINE LEARNING CONTENT (MOOCs) THAT PROVIDE TRAINING FOR SKILLING, UPSKILLING AND RESKILLING IN DIGITAL AND 4IR COURSES THAT ARE INTERNATIONALLY RECOGNISED AND ACCREDITED.

1. PURPOSE

The National Electronic Media Institute of South Africa (NEMISA) hereby invites experienced and suitably qualified service providers to submit bids for the provision of Online learning content (MOOCs) that provide training for skilling, upskilling and reskilling in Digital and 4IR courses that are internationally recognised and accredited, as well as courses from industry leaders and experts.

2. BACKGROUND

NEMISA is a training provider in creative media and digital skills. Recently, the mandate was expanded to include 4IR skills for South African citizens. The organisation seeks to acquire internationally recognised and accredited online learning content that can be used to train South African citizens through the **NEMISA In-House Online Learning Platform**.

3. CONTRACT PERIOD

Period of 24 Months

4. SCOPE OF WORK

NEMISA is looking for a partner to provide **online learning content (MOOCs)** that is relevant to the skilling, upskilling and reskilling of South African students, particularly in the fields of ICT and 4IR both technical skills and soft skills.

5. FUNCTIONALITIES

The functionalities must include but not be limited to:

- The provider of the learning content must be able to provide a **large variety** of, completed, tested and proven online learning courses (MOOCs)

- Courses must be internationally recognised and accredited. (Provided and created by well know, acclaimed and recognised international Universities, with a cultural spread i.e. Not only one from country)
- Course providers should not only be theoretical, (academic) but should also include content from international ICT industry leaders and experts in cutting-edge topics like IT Support, Cloud, and Data Science. (Global leading technology companies)
- Content must be available directly from the content provider, without having to access any third-party sites.
- Already completed courses should provide options for subtitles in one or more official South African Language. (Zulu, Xhosa, Southern Sotho, Afrikaans or Tswana – at least 2 languages must currently be ready for use)
- Courses should include assessments, labs and projects that provide deep skilling that allows employers the ability to verify learning has taken place.

6. TECHNICAL REQUIREMENTS

- The learning content provider should have experience of running courses accessed by upward of 50 000 students.
- The learning content provider must have extensive experience in running national scale public sector programs. (provide at least 10 countries with results)
- The provider should have the ability to allow NEMISA to easily create projects that, if needed, can be hosted on the providers learning portal under a NEMISA branded sub-portal. (There should also be functionality for African language subtitles)
- Projects should incorporate virtual machine functionality so that learners do not need to download additional software.
- NEMISA should be able to access an analytics dashboard that allows admins to measure and report on:
 - learner progression through courses and programs,
 - view learner satisfaction with courses,
 - monitor utilisation changes,
 - track skill building across detailed domains,
 - communicate with and motivate learners via a combination of pre-set and custom templates targeted at common program barriers.
- Weekly reports should be sent to NEMISA, tracking student registration and progress
- The service provider should be able to provide specific scientifically and statistically backed advice on skills needed for different sectors and which courses speak to the various skills.
- The service provider should offer a skill advisory support system with a dedicated content advisory team, which can pull data from global learners into essential skill maps across industries (Skill maps must have verifiable statistical backing)
- The service provider should provide support for benchmarking NEMISA's and South Africa's competitiveness against global leaders and regional competitors. (Verifiable, Scientific and statistical backing)
- The service providers learning platform must be able to link to NEMISA's Online Learning Platform via API's

- The service provider should be able to assist in the creation of the API's should NEMISA require it.

Language: Language to be used for on the main site is English (with some course subtitles in at least **two** African Languages)

User Interface: Menu-driven interface compatible with all browsers for mobile devices, tablets, and computers (any OS) – the user experience to be the same way on mobile phones as on their laptops.

7. UPDATES

The appointed service provider will provide NEMISA with 7 days' notice before taking the site offline for maintenance or updates.

ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

The bidder that score less than **80%** of the points available for functionality will be eliminated from further consideration.

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

2.4 DETERMINATION OF SCORE FOR PRESENTATIONS

2.4.1 NEMISA will not call for presentations.

2.5 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

2.5.1 Bids that score less than **80%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

2.6 PRICE AND B-BBEE STATUS LEVEL POINTS

Section A 3: Evaluation Process/ Criteria

- 2.6.1 All remaining bids will be evaluated as follows:
- 2.6.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 2.6.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 2.6.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.
- 2.6.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.5.1 or to a lower scoring bid on justifiable grounds.

2.7 ADJUDICATION OF BID

- 2.7.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.

 - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
 - 3) Any other requirement prescribed in terms of the B-BBEE Act;
- (i) **“QSE”** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
