4.1 Quotations received late shall not be considered. A quotation will be considered late if it arrived even one second after 11:00 or any time thereafter. Quotations received late shall be returned unopened to the respondent. SOURCING OF A SERVICES PROVIDER TO UNDERTAKE AN IMPACT ASSESSMENT STUDY ON BEHALF OF NEMISA

1. BACKGROUND

NEMISA is a national public entity listed under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008.

NEMISA invites suitable service providers to undertake an impact assessment study on the Programmes that NEMISA has delivered in 2020/21 financial year. The study will focus on digital literacy programmes and the Specialist ICT Skills courses that were delivered in the period. This impact assessment project will be guided by NEMISA's approved Monitoring and Evaluation Framework. The study is expected to collect, analyse data and report on the changes brought by the NEMISA's training programmes in the lives of the beneficiaries.

2. PURPOSE

The purpose of this assignment is to enable NEMISA to measure how its training programmes are contributing to inclusion into the digital economy and the economy at large of its programme beneficiaries thus this translating to improved livelihoods and economic participation. The study should also assist NEMISA to review the effectiveness of its training programmes to be studied and make recommendations to improve the success of the programmes.

3. SCOPE OF WORK

The Study will be undertaken on the Digital Literacy Programme and the Specialist ICT courses delivered by NEMISA in the financial year 2020/21

3.1. NEMISA shall be responsible for:

3.1.1 Making available to the appointed service provider a database of beneficiaries who participated in the programmes to be studied;

3.1.2 Introducing the appointed service provider to the stakeholders whom the project will reach;

- 3.1.3 Allocating a NEMISA official to be part of the project management team;
- 3.1.4 Review and provide feedback to the service provider on proposed research process, methodologies, and tools to be utilised for the study including the draft impact assessment report; and
- 3.1.5 Respond timely to all queries that the appointed service provider may submit about the project.

3.2. The service provider(s) shall be responsible for:

- 3.21. Submit as part of the proposal a research design that proposes the appropriate research methodology for the study, proposed data collection processes and tools, data analysis processes and tools including the proposed structure of the report to be delivered at the end of the study. The proposed methodology must lead to the collection of reliable data to be used in the research report.
 - 3.2.1. The proposal must include the proposed sampling methods.
 - 3.2.2. The proposal must also include possible risks to the project and how will such risks be mitigated.
 - 3.2.3. Submission of a proposed project plan for the study is a requirement.
 - 3.2.4. Propose mechanisms that will ensure that maximum responses are received from the participants in the study.
 - 3.2.5. The proposal must indicate how limitations of the study will be identified and reported.
 - 3.2.6. Submit the impact assessment report inclusive of recommendations before 31 March 2021.

NOTE: The service provider will be required to provide assurance of no conflict of interest in any candidate. Should any conflict of interest arise, the service provider will be required to withdraw its involvement and NEMISA may then elect to appoint another service provider.

4. COMPETENCY AND EXPERIENCE REQUIREMENTS

- 4.1. Respondents shall clearly indicate the names of the resources / Team that will be providing the service to NEMISA as well as a comprehensive CV(s) of the proposed resource(s) / team.

- 4.2. The successful service provider(s) shall have a proven track record in undertaking impact assessment studies, tracer studies or similar projects and shall have a minimum of 5 years' experience in the field.
- 4.3. Respondents shall provide a list of assignments where similar services were provided within the past five years.
- 4.4. Respondents shall provide the names and contact details of at least three clients (preferably in the public sector) for whom a similar service was provided within the past five years.

9.2.2 The score for functionality shall be calculated as follows:

9.2.2.1.1 Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.

9.2.2.1.2 The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual respondent for functionality.

9.3 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

- 9.3.1 Quotations that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

9.4 PRICE AND B-BBEE STATUS LEVEL POINTS

- 9.4.1 All remaining quotations will be evaluated as follows:
- 9.4.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 9.4.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.
- 9.4.4 The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.
- 9.4.5 The Evaluation Committee may recommend that the contract be awarded to the respondent obtaining the highest aggregate mark as determined by 1.4.4 or to a lower scoring quotation on justifiable grounds.

9.5 ADJUDICATION OF BID

- 9.5.1 The relevant award structure will consider the recommendations and make the final award. The successful respondent will usually be the service provider scoring the highest number of points or it may be a lower scoring quotation on justifiable grounds or no award at all.
