4. LATE SUBMISSIONS

- 4.1 Quotations received late shall not be considered. A quotation will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and quotations arriving late will not be considered under any circumstances. Quotations received late shall be returned unopened to the respondent. Respondents are therefore strongly advised to ensure that quotations be despatched allowing enough time for any unforeseen events that may delay the delivery of the quotation.
- 4.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.
- 4.3 Quotations sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises. - 5.3 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

TERMS OF REFERENCE (TOR)

SOURCING OF SUITABLEY QUALIFIED SERVICE PROVIDER TO DEVELOP BUSINESS CONTINUITY PROGRAMME FOR NEMISA

1. BACKGROUND

NEMISA is a national public entity listed under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008. NEMISA is an entity of the Department of Communications and Digital Technologies and its mandate is to deliver digital skills to South Africa's citizens. Historically NEMISA has also provided training programmes in the creative media space.

NEMISA has become increasingly reliant on Information and Communication Technology (ICT) and Computer Information Systems (IS) as a vital part for the execution of most of its business processes. Therefore, it becomes imperative that business operations and systems function efficiently and effectively without excessive interruptions at all NEMISA office locations. This will ensure that NEMISA's Strategic Plan, Annual Performance Plans, DCDD Strategies and the National Plans such as the National Development Plan are achieved as required.

In the light of the above, NEMISA invites suitably qualified service providers to develop a comprehensive Business Continuity Programme that will build organisational resilience such that it continues the delivery of products and/or services at acceptable predefined levels following a disruptive incident.

2. PURPOSE

The purpose of this assignment is to provide NEMISA with business continuity programme that will be responsive to a wide-range of critical operational concerns, including the need to drive reduced operational losses resulting from disastrous

events, control costs, respond to increasing regulatory requirements, and plan for unpredictable business disruptions or catastrophic disasters.

This business continuity programme is an on-going effort to ensure that business continuity and recovery requirements are addressed, resources are allocated, and processes and procedures are completed and rehearsed across NEMISA.

3. SCOPE OF WORK

3.1. NEMISA shall be responsible for:

- 3.1.1 Making available to the appointed service provider information and documents required to carry-out the project.
- 3.1.2 Introducing the appointed service provider to the key stakeholders required to carry out the project.
- 3.1.3 Allocating a NEMISA official / task team to be part of the project management team.
- 3.1.4 Review and provide feedback to the service provider on proposed project plan, methodology, tools and resources to be utilised for the delivery of the project including the draft reports; and
- 3.1.5 Respond timely to all queries that the appointed service provider may submit about the project.

3.2. The service provider(s) shall be responsible for:

- 3.1.6 Submit as part of the proposal a proposed project plan, methodology, tools and resources to be utilised for the delivery of the project.
- 3.2.1. The proposal must also include possible risks to the project and how will such risks be mitigated.
- 3.2.2. Submission of a proposed comprehensive Project Implementation Plan is a requirement and should conform at least to the best practice i.e. ISO/IEC 15288 or equivalent standard and PMBOK which must include, but not be limited to the following:
 - 3.2.2.1 Detailed Project Plan including milestones and project phases
 - 3.2.2.2 Project Resource Plan that describes the key resources who will be assigned to the project including clearly indicating the Project Manager / Leader and Project manager's relevant certification.

3.2.2.3 Project Execution Plans detailing the execution and monitoring of the project

3.2.2.3 Project Risk management plan

3.2.3. Conduct a high-level gap analysis - Establishing what elements of a business continuity programme already exist, review these for adequacy and ensure that business continuity programme implementation, accommodates and builds upon already existing sub-elements of a BCM. Examples of such sub-elements may include amongst others Disaster Recovery Policy and Plan

3.2.4. Develop Business Continuity Policy and Framework in line with applicable laws & legislations, and international best practice standards.

3.2.5. Conduct a Business Continuity Risk and Vulnerability Assessment

3.2.6. Conduct a Business Impact Analysis organisation-wide

3.2.7. Develop Business Response Plans (BRPs) and Business Continuity Plans (BCPs) based on the outcomes of Business Impact Analysis and Business Continuity Risk and Vulnerability Assessment. Business Continuity Plans to be developed are as follows:

3.2.7.1 Business Recovery Plans/strategies – (for each environment)

3.2.7.2 Business Resumption Plan – (Organisational overall BCP)

3.2.7.3 Review and align the existing Disaster Recovery Plan with the entire BCP

3.2.6.5 Incident and Crisis Management Plan

3.2.7.6 Emergency Evacuation / Response Plan (to align and review the current Plan)

3.2.7.7 Strike Management Action Plan

3.2.8. Desktop Testing of ICT BCPs (which must include DRP & BCP Test Plans)

3.2.9. Report final draft documents to the Executive Committee (EXCO) and Audit & Risk Committee (ARC)

3.2.10. BCM introductory training for the Response team on the Business Continuity Programme to provide knowledge and skills for responding to significant incidents using the suite of plans that have been developed.

3.2.11. Submit the comprehensive business continuity programme as outlined in the scope of work in Sub-Section 3.2 by the end of the project term / duration as stipulated under Section 4.

NOTE: The service provider will be required to provide assurance of no conflict of interest in any candidate. Should any conflict of interest arise, the service provider will be required to withdraw its involvement and NEMISA may then elect to appoint another service provider.

4. DURATION

4.1 The estimated period of the Business Continuity Management Consultancy has been scheduled for six **(6) months** from the date of the receipt of the Purchase Order/Appointment Letter to final output delivery.

1.2.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual respondent for functionality.

1.3 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

1.3.1 Quotations that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.4 PRICE AND B-BBEE STATUS LEVEL POINTS

1.4.1 All remaining quotations will be evaluated as follows:

1.4.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.

1.4.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.

1.4.4 The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.

1.4.5 The Evaluation Committee may recommend that the contract be awarded to the respondent obtaining the highest aggregate mark as determined by 1.4.4 or to a lower scoring quotation on justifiable grounds.

1.5 ADJUDICATION OF BID

1.5.1 The relevant award structure will consider the recommendations and make the final award. The successful respondent will usually be the service provider scoring the highest number of points or it may be a lower scoring quotation on justifiable grounds or no award at all.
