Quotations received late shall be returned unopened to the respondent. SOURCING OF A SERVICES PROVIDER TO UNDERTAKE DATA ANALYSIS AND PRODUCE AN IMPACT ASSESSMENT REPORT ON BEHALF OF NEMISA

1. BACKGROUND

NEMISA is a national public entity listed under the PFMA and registered as a non-profit Company under the Companies Act 71 of 2008.

NEMISA invites suitable service providers to undertake data analysis and produce an impact assessment report on the selected Programmes that NEMISA has delivered in 2020/21 financial year. The study will focus on digital literacy programmes, Specialist ICT Skills and Creative Media courses that were delivered in the period. This data analysis and reporting will be guided by NEMISA's approved Monitoring and Evaluation Framework. NEMISA will avail the data to the successful service provider. The study is expected to analyse data and report on the changes brought by the NEMISA's training programmes in the lives of the beneficiaries.

2. PURPOSE

The purpose of this assignment is to enable NEMISA to measure how its training programmes are contributing to inclusion into the digital economy and the economy at large of its programme beneficiaries thus this translating to improved livelihoods and economic participation. The study should also assist NEMISA to review the effectiveness of its training programmes to be studied and make recommendations to improve the success of the programmes.

3. SCOPE OF WORK

The Study will be undertaken on the Digital Literacy Programme Specialist ICT and Creative Media courses delivered by NEMISA in the financial year 2020/21

3.1. NEMISA shall be responsible for:

- 3.1.1 Making available to the appointed service provider data of beneficiaries who participated in the programmes to be analysed.
- 3.1.2 Allocating a NEMISA official to be part of the project management team;
- 3.1.3 Review and provide feedback to the service provider on proposed research data analysis process, methodologies, and tools to be utilised for the study including the draft impact assessment report; and
- 3.1.4 Respond timely to all queries that the appointed service provider may submit about the project.

3.2. The service provider(s) shall be responsible for:

- 3.21. Conducting data analysis on the programmes / projects that NEMISA has offered and compile an impact assessment report.
- 3.22. Submit as part of the proposal appropriate data analysis approach of the available / provided research data.
- 3.23. An impact assessment report must be compiled following the available data analysis for the selected programmes / projects that NEMISA has offered.
 - 3.2.1. The proposal must also include possible risks to the project and how will such risks be mitigated.
 - 3.2.2. Submission of a proposed project plan for the study is a requirement.
 - 3.2.3. The proposal must indicate how limitations of the study will be identified and reported.
 - 3.2.4. Submit the draft impact assessment report by the 26th March 2021 and the final report with inclusive of recommendations before 31 March 2021.

NOTE: The service provider will be required to provide assurance of no conflict of interest in any candidate. Should any conflict of interest arise, the service provider will be required to withdraw its involvement and NEMISA may then elect to appoint another service provider.

4. COMPETENCY AND EXPERIENCE REQUIREMENTS

- 4.1. Respondents shall clearly indicate the names of the resources / Team that will be providing the service to NEMISA as well as a comprehensive CV(s) of the proposed resource(s) / team.

- 4.2. The successful service provider(s) shall have a proven track record in undertaking impact assessment studies, tracer studies or similar projects and shall have a minimum of 5 years' experience in the field.
- 4.3. Respondents shall provide a list of assignments where similar services were provided within the past five years.
- 4.4. Respondents shall provide the names and contact details of at least three clients (preferably in the public sector) for whom a similar service was provided within the past five years.

1.2.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual respondent for functionality.

1.3 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

1.3.1 Quotations that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.4 PRICE AND B-BBEE STATUS LEVEL POINTS

1.4.1 All remaining quotations will be evaluated as follows:

1.4.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.

1.4.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.

1.4.4 The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.

1.4.5 The Evaluation Committee may recommend that the contract be awarded to the respondent obtaining the highest aggregate mark as determined by 1.4.4 or to a lower scoring quotation on justifiable grounds.

1.5 ADJUDICATION OF BID

1.5.1 The relevant award structure will consider the recommendations and make the final award. The successful respondent will usually be the service provider scoring the highest number of points or it may be a lower scoring quotation on justifiable grounds or no award at all.
