4 LATE SUBMISSIONS

4.1 Bids received late shall not be considered. A bid will be not considered late even if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bid arriving late will not be considered under any circumstances. Bid received late the bidder will be informed in writing regarding late submission. Respondents are therefore strongly advised to ensure that quotations be despatched allowing enough time for any unforeseen events that may delay the delivery of the quotation.

4.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

4.3 Bid sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises. Quotations received at the physical address after the closing date and time of the quotation, shall therefore be deemed to be received late. Quotations sent by email shall be deemed to have been received at the time indicated in the inbox of the recipient.

5 PAYMENTS

5.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

5.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

5.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

5.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

5.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the quotation is awarded).

5.2 The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

7. **TERMS OF REFERENCE (TOR)**
Security Service contract until 31 May 2022

The security officers will be required to perform the following security duties:

Act as authorised officers in terms of Control of Access to Public Premises and Vehicles Act 53 of 1985 as amended, which entail requesting a person who require entry to:

Furnish his/her name, address and any relevant information required by the authorized officer.

Produce proof of his/her identity to the satisfaction of the authorised officer. Declare whether he/she has any dangerous object in his possession or custody or under his control.

Declare what the contents of any vehicle, suitcase, attached case, bag, handbag, folder, envelope, parcel or container of any nature which he has in his possession or custody or under his control, and show those contents to him.

Subject him/her and anything which he/she has in his/ her possession or custody or under his/her control to an examination by electronic or other equipment in order to determine the presence of any dangerous object.

Hand to an authorized officer anything which he/she has in his possession or custody or under his/her control for examination or custody until he/she leaves the premises.

Perform Access Control duties which entail:

Recording visitor's in a Visitors Registers and booking them out on departure.

Recording details of all NEMISA staff and students' members visiting the premises after normal working hours in After-hours register.

Recording all events/incidents in the proscribed Occurrence Book.

Advising the NEMISA Facilities Management personnel of all access control implications, deficiencies, or imminent or perceived security crime risks occurring at the entrance or its imminent or perceived security crime risks occurring at the entrance or its vicinity.

Ensuring that traffic congestion do not occur at the entrance during peak hours.

Perform other access control duties as may be instructed from time to time.

Patrol duties:

Patrol duties shall entail patrolling the NEMISA premises regularly day and night.

The service provider shall provide a patrol monitoring equipment or guard track which will be used as patrol tool for the security officers after hours.

Protect the NEMISA staff and students against any injuries, death or any other as criminal Schedule 1 offence of the criminal procedure act 51 of 1977, as amended.

Protect the property of NEMISA on the site against theft, vandalism or other criminal activity

Ensure that all strategic installation, vulnerable points or key areas are frequently checked to maintain their safety and security against theft, vandalism or any other criminal activity.

Management Monthly meetings

Regular meetings of a general nature may be convened to discuss • Risk register and compensation events • Overall contract progress and feedback Meetings of a special nature may be convened at times and at NEMISA offices. Records of these meetings are submitted to the Facilities Manager by the person convening the meeting within 5 days of the meeting. All meetings are recorded using minutes and a register prepared and circulated by the person who convened the meeting.

Contract management, supervision and key people

The Contractor's Site Manager/ Supervisor ensures that only competent persons be allowed to work on the premises. NEMISA personnel are entitled to verify the qualifications of the Contractor and its employees. The Contractor's Supervisor must be knowledgeable about the conditions and the scope of work contained in this contract and can render the service. NEMISA may, having stated reasons, instruct the Contractor to remove a key person. The Contractor then arranges that, after one day, the key person has no further connection with the service contained in this contract. The Contractor may not replace any of the key persons, without prior a proper disciplinary process and written request and approval thereof from the NEMISA's Facilities Manager. The contractor to appoint specialised person or company to do risk assessment in the site of NEMISA, this should be done at least twice a year in consultation and approval of NEMISA. The report with recommendations to be produced forwarded directly to NEMISA. The company or person who would have been appointed to be contracted for the duration of the contract. The contractor must also pay a retainer fee to the subcontractor for the purpose of providing incident investigation in terms OHS and security.

Police clearance

All Contractor personnel are to undertake police clearance. Certificates to be provided to the Contract Manager at least 2 weeks before commencement of work. The Contract Manager reserves the right to refuse entry to all persons whose criminal record indicates that their presence on the site might create an unsafe and insecure environment to NEMISA building. 1.2 DETERMINATION OF SCORE FOR FUNCTIONALITY

1.2.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.

- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual respondent for functionality.

1.3 DETERMINATION OF SCORE FOR PRESENTATIONS

- 1.3.1 NEMISA will not call for presentations.

1.4 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

- 1.4.1 Quotations that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

2.1 PRICE AND B-BBEE STATUS LEVEL POINTS

- 2.1.1 All remaining quotations will be evaluated as follows:
- 2.1.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 2.1.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.
- 2.1.4 The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.
- 2.1.5 The Evaluation Committee may recommend that the contract be awarded to the respondent obtaining the highest aggregate mark as determined by 1.5.4.

2.2 ADJUDICATION OF BID

- 2.2.1 The relevant award structure will consider the recommendations and make the final award. The successful respondent will usually be the service provider scoring the highest number of points or it may be a lower scoring quotation on justifiable grounds or no award at all.
