## **5 LATE BIDS**

5.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

5.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

5.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

## **6 PAYMENTS**

6.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

6.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

6.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

## **TERMS OF REFERENCE (TOR)**

SOURCING A SERVICE PROVIDER TO ASSIST NEMISA WITH THE REVIEW OF TRAINING PROVISION QUALITY MANAGEMENT SYSTEM (QMS) TOWARDS THE RE-ACCREDITATION AS A SKILLS DEVELOPMENT PROVIDER

### **1. INTRODUCTION**

The National Electronic Media Institute of South Africa was established as a non-profit institute for education in terms of the Companies Act (1973) and is listed as a schedule 3A public entity in terms of the Public Finance Management Act (1999).

NEMISA derives its mandate from the Department of Communications and Digital Technology (DCDT), and DCDT's constitutional function is e-skilling the nation for equitable prosperity and global competitiveness.

### **2. BACKGROUND**

The historical mandate of NEMISA was provision of training programmes in creative media including broadcasting, animation, and graphic design. This mandate has since been expanded to include 4IR and Digital skills programmes, it is within this context that a need was identified to reposition NEMISA as a Digital skills institute of choice. NEMISA's main site is in Parktown, Johannesburg while it is represented in other provinces of South Africa through national CoLabs situated in universities.

The Institute is an accredited skills development provider with the Media, Information and Communication Technologies Sector Education and Training Authority (MICT SETA) since 2007 offering eleven (11) media related qualifications which fall under the guardianship of the MICT SETA. The two government departments merger and the revised mandate for NEMISA it is therefore imperative that the institute seeks the services of a qualified and experienced Quality Management System (QMS) developer to review the current manual and ensure new government legislation, e-learning, impact of COVID-19 and the Fourth Industrial Revolution requirement are incorporated.

The Education and Training Quality Assurance Regulation (R1127) gives the following definition for Quality management System "The combination of processes used to ensure that the degree of excellence specified is achieved." In the Institutes journey to being a centre of

excellence, the implementation of a relevant Quality Management System (QMS) has the function of setting internal rules that create and sustain a “quality” culture throughout the Institute, that secure continuous improvement and identify customers and beneficiaries.

The National Electronic Media Institute of South Africa therefore requires qualified service provider who will assist in the fulfilment of the mandate and vision, by developing a Quality Management System that will result in the relevant Education and Training Quality Assurance (ETQA) awarding the Institute registration as a Skills Development Provider.

### **3. PURPOSE**

NEMISA seeks to appoint an external service provider to assist in the review of training provision Quality Management System (QMS) towards full accreditation as a skills development provider with the relevant Education and Training Quality Assurance (ETQA).

### **3. SCOPE OF WORK**

The National Electronic Media Institute of South Africa (NEMISA) is poised to play an important role in contributing towards digital skills development and the ushering of the 4th Industrial Revolution. The overall objective of the project is to assist NEMISA to review, improve the National Electronic Media Institute of South Africa (NEMISA) training Quality Management System (QMS), Manual (policies, procedures, and templates) and apply for re-accreditation with the relevant Education and Training Quality Assurance (ETQA) for skills development provider full accreditation.

The service provider(s) shall render and be responsible for the tasks below:

- 3.1 **A detailed desktop review and report** - Research current local and international trends and relevance to NEMISA.
- 3.2 **Desktop review of the current NEMISA Quality Management Systems Manual** – Analyse current manual and all related policies; discussion with NEMISA management.
- 3.3 **Compile a comprehensive NEMISA Quality Management System** - policies, procedures, flowcharts, and templates that are relevant to the new NEMISA mandate and meet ETQA requirements.
- 3.4 **Learning material alignment** – current accredited learning material alignment to QMS and ensure compliance to ETQA requirements.
- 3.5 **Application for re-accreditation** – Submit and project manage the application (start to end) for skills development provider re-accreditation with the relevant ETQA.



3.6 **Skills transfer** - induct and orientate relevant staff on the contents of the QMS Manual subsequent to NEMISA approving the manual

3.7 **NEMISA accreditation as a skills development provider** – deliver full accreditation certification for NEMISA against current list of full qualifications and skills programmes.

3.8 **Presentation of final QMS manual and closeout project report** – Project close out report and presentation to NEMISA management.

#### **4. COMPETENCY AND EXPERIENCE REQUIREMENTS**

The successful service provider is expected to submit to NEMISA a detailed proposal outline (work plan and approach). The proposal outline and brief should cover but not be limited to the following items:

- 4.1 Respondents shall clearly indicate the names and proposed roles of the resources that will be providing the service to NEMISA as well as a comprehensive CV(s) of the proposed resource(s)
- 4.2 May it be noted that the experience of the key resource i.e., Project Leader shall carry more weight in the evaluation of this requirement.
- 4.3 Curriculum Vitae's and applicable certificates of personnel that will be responsible for conducting any sort of work in the project.
- 4.4 Provide two reference letters stating that similar work has been delivered by the service provider. The reference letters are to come from different companies where it has successfully performed a similar service (e.g: skills development consultancy; training material development and accreditation; training QMS/policy development and entity accreditation with ETQA's).
- 4.7 Scope of work – including boundaries and limits of the project
- 4.5 Duration and delivery timeframes to undertake the work (Gantt chart or similar)
- 4.6 Outputs and deliverables
- 4.7 Exclusions
- 4.8 Cost – including any specialist cost and travel etc.

#### **5. PROJECT SCHEDULE**

It is anticipated that the work will commence upon acceptance and signing of a contract with an appropriate a service provider appointed by NEMISA, and it is expected that the project will be completed within **three (3) months** of commencement of the project.

##### **5.1 Timelines**

- 5.1.1 The successful Service provider is required to deliver a comprehensive Quality Management System (QMS) with the accompanying, policies, procedures, and templates as stipulated in the accreditation requirements of an ETQA in **two (2) months** from contracting.
- 5.1.2 The project should be concluded by 31 October 2021.

5.1.3 To induct and orientate relevant staff on the contents of the QMS Manual over a period of **one (1) month** after successful delivery of the QMS Manual to NEMISA.

## **6. PROJECT LOCATION**

The project is located at the NEMISA main campus in Parktown, Johannesburg South Africa.

## **7. CONFIDENTIALITY**

A contractual pre-requisite is to comply with the Entity's Confidentiality Agreements. It must be noted that all company information is confidential. Once appointed, the successful bidder will be expected to enter into a Confidentiality Agreement with the Entity.

## **8. DETERMINATION OF SCORE FOR FUNCTIONALITY**

The evaluation criteria and weights for functionality as indicated in the table below, will apply, the bidders are required to meet **70%** to be able to move to the next stage of evaluation.

1.2.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.

- ❑ The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

### **1.3 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY**

- 1.3.1 Bids that score less than **70%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

### **1.4 PRICE AND B-BBEE STATUS LEVEL POINTS**

- 1.4.1 All remaining bids will be evaluated as follows:
- 1.4.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.
- 1.4.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- 1.4.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.
- 1.4.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.4.4 or to a lower scoring bid on justifiable grounds.

### **1.5 ADJUDICATION OF BID**

- 1.5.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.

- 1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (g) **“prices”** includes all applicable taxes less all unconditional discounts;

  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act;
- (i) **“QSE”** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
